Principles of Personal Data Processing

Purpose of Personal Data Processing

The purpose of processing is the authentication and authorization of the user (data subject) for the purposes of accessing the application and pairing information about the passage of applications with the user.

Categories of Persons whose personal Data are Processed

EVE Technologies processes personal data of the following categories of persons (data subjects) in a mobile application:

Categories of Personal Data Processed

EVE Technologies processes the following personal data provided in the mobile application by individual persons (data subjects):

primary electronic address, or name, surname.

Legal Reasons for Personal Data Processing

The processing of personal data in the application takes place with the consent of the data subjects.

Personal Data Transfer

EVE Technologies does not pass on personal data to third parties.

Personal Data Storage Period

Personal data is stored only for the duration of the purpose for which consent to the processing was granted, i.e. for the period of using the CzechME mobile application.

Exercise of Data Subjects' Rights

The data subject shall be entitled to exercise their rights under the GDPR against the controller, either
